The trust service assessed is characterized by the identification method(s) as follows:

- Physical registration via MitID-RA with physical presence of the applicant. This option is open for all applicants.
- Self-service via MitID ID App. This option is open for all applicants. The ID App consists of the following components:
 - MitID Mobile App MitID App
 - enhanced security MitID chip
 - MitID code display MitID Audio code reader
 - MitID Password
- Physical registration in remote settlements via MitID-RA proxy with physical presence of the applicant. This option is available for end-users living in remote Greenlandic settlements unable to apply through one of the first two options.
